What is a Clerkship?

A law clerkship is a valuable opportunity for law students to gain practical experience and insight into the legal profession. Clerkships are offered by law firms, government agencies, and judicial offices to penultimate or final-year law students.

For students aspiring to work in private practice, a clerkship stands as a important phase in the journey. Although it isn't obligatory, it serves as a preferred recruitment route for law firms. Often, clerks transition into Graduate roles post-program. While common, it's essential to know this isn't the sole path to private practice.

The majority of mid and top tier law firms offer formal seasonal clerkship programs. Most clerkships range from 4-15 weeks but the number of weeks differs depending on the firm and firm location.

Clerkship programs largely include:

- Learning the tools for professional growth and development in the legal profession. As a clerk you will be exposed to experienced legal professionals, with unlimited opportunities for learning.
- The opportunity to connect with legal professionals and expand your professional network.

General tasks that clerks complete include:

- Performing legal and factual research
- Drafting and summarising legal documents, checking for accuracy
- Preparing correspondence, written reports and performing records research
- Organising and tracking case files
- Writing clients memos
- Recording client meetings and drafting daily correspondence, including letters and legal documents

In 2023, we were awarded Wellness Initiative of the Year in the Lawyers Weekly Awards.

What significant work has your firm recently undertaken?

We're proud to have recently worked on one of the biggest developments in regional Victoria, advising Development Victoria and the broader Victorian Government team on the successful financial close of the Nyaal Banyul Geelong Convention and Event Centre project. This project will be a major driver of jobs and economic growth in regional Victoria, supporting 1,450 jobs during construction and 700 jobs once complete.

Supporting the largest wind farm being built in NSW was another highlight. We worked with our long-term client Squadron Energy, a portfolio company of Tattarang, on its successful construction financing of the Uungula Wind Farm.

We advised Singapore incorporated gas and exploration company Conrad Asia Energy Ltd (ASX: CRD) on its placement and security purchase plan to raise approximately \$16 million, as well as PAR Technology Corporation (NYSE: PAR) (PAR) on its acquisition of TASK Group Holdings Limited (ASX:TSK) (TASK) by way of a scheme of agreement - a transaction valued at approximately AUD \$330 million.

In the affordable housing space, we supported Housing Australia on the legal aspects of its key housing initiatives, the Housing Australia Future Fund Facility and the National Housing Accord Facility. These initiatives aim to improve housing outcomes for Australians and collectively support the delivery of 20,000 new social homes and 20,000 new affordable homes across Australia over the five year program.

What kind of pro bono work does the firm engage in?

Our pro bono work has always been about access to justice. It's embedded into our culture and is a fundamental part of who we are as a firm. We were the first large Australian law firm to establish an in-house pro bono practice; the first to appoint a full-time pro bono partner; and the first to sign the National Pro Bono Target. We act for low income and vulnerable people who cannot obtain Legal Aid, and for not-forprofit organisations which support them. This includes First Nations people and organisations, people who are homeless or at risk of homelessness, survivors of domestic violence and sexual assault, people who have experienced elder financial abuse and people been sexually harassed, discriminated against, exploited and underpaid at work. We continue to pioneer compensation pathways for people held in slavery in Australia. We champion the Health-Justice Partnership model. We are a participating member firm of the Blue Pacific Pro Bono Collaborative, providing pro bono legal support to sustainable development projects that address the climate crisis in the Pacific.

We have a dedicated Pro Bono team and have made pro bono work a fundamental part of what it means to be a lawyer at Clayton Utz. In FY23, more than 85% of our lawyers and partners conducted 49,423 pro bono hours (at an average of 57.6 pro bono hours per FTE).



Make a great first impression

Consider your personal brand, how you want to be perceived and recognised in terms of your strengths. The best way to create a good impression is by being authentic.

A great attitude, enthusiasm for any task and the ability to quickly build rapport is an asset.

Remember, a 3.5 to 4-week clerkship is an extended interview for a graduate position in locations with multiclerkship opportunities.

Show initiative and seek opportunities

Have a clear picture of what you want from your clerkship, what you want to learn about the firm, and the type of work you want to get involved in.

Take the initiative to get to know your team as well as other practices across the firm, meet as many people as possible and try to get involved in different types of work, projects and activities.

Communication is vital

Take on various work for different people across the team, but don't forget the importance of managing your priorities.

Clerkships involve several training sessions and activities. You will also be completing various projects for people across your team; make sure you keep your team and supervisor updated on your workload and training schedules to ensure your success.



Get feedback

A clerkship is an excellent opportunity for you to learn and develop your legal knowledge and skills, remember to request feedback after completing tasks, as acting on this feedback is a great way to demonstrate your ability to learn quickly – an essential skill for junior lawyers.

Take the time to follow up with the team members that have assigned you tasks and get their thoughts on the work you have completed - just be conscious of their workload and the timing.

Develop your networks

Speak to as many people as possible. This is your opportunity to find out if Ashurst is the place you want to begin and grow your career.

Take every opportunity to meet people from across the firm to learn about the practice groups, and if they are people you would like to work with in the future.

Lastly, take the time to get to know your fellow clerks - you may be colleagues one day!

Early careers at MinterEllison



Matina Kouparitsas, Lawyer, Canberra shares her career journey, hints and tips.

Tell us a bit about yourself and your time so far at MinterEllison?

I initially joined MinterEllison as a Vacation Clerk in 2021 before transitioning into the role of a Paralegal in 2022 while I was completing my law degree. I became full-time at the beginning of 2023, when I commenced the Graduate program. I have been very lucky to have spent the time I have so far at Minters, and have learned so much and met so many talented people, as well as formed strong friendships.

What was it that attracted you to MinterEllison?

I was drawn to the reputation of the firm in terms of its inclusive and positive workplace culture, the interesting work and learning experiences that I would be exposed to at Minters, and the genuine and welcoming people I met throughout the interview process. As the clerkship process progressed, what really stood out to me about Minters was the friendliness and openness of everyone I spoke with, and their willingness to volunteer their time to answer all my questions as a clerkship candidate. To this day, I think the people really make a difference at Minters.

What rotations have you done?

As part of both the graduate and clerkship programs, I have rotated through the Real Estate, and Projects Infrastructure and Construction teams. Both teams have helped me to grow my skills as a transactions lawyer, and have provided me with an interesting variety of tasks to grow my skills in different areas, as well as lots of client engagement! I have also found it really satisfying to see the physical manifestation of various projects I have worked on being built around Canberra.

How has the firm supported you through your first years as a Lawyer?

The firm has been very supportive of me through my first year as a Lawyer. As a junior, there is so much to learn, and it can be overwhelming at times. Everyone at Minters from my buddy up to the Partner has been super supportive of my development, and have been really open to sharing their knowledge, and being really patient when answering questions. It makes a massive difference that everyone is so approachable to ask questions and learn from, and it has made for a really great working and learning environment. I have also taken part in the WISE mentoring program, where I was assigned a mentor from a different team that I have not yet rotated through. It is really helpful to have someone to ask more general questions about work in a trusting environment.

What has been a highlight at work for you?


I had the opportunity to attend an offsite client meeting alone for one of the major projects I have been working on (since I was a clerk!). It was a really good opportunity as it allowed me to build an in person relationship with the client, and really made me feel like the team trusted me. It also allowed me to have first cut of most of the work that arose out of that meeting, and was a great learning experience.

Have you had the opportunity to participate in any of the firms internal networks or committees?

I have been lucky to be involved in the WISE (Women, Inclusion, Support, and Equality) network and the Junior Professional's Committee (JPC) during my time at the firm. Both have allowed me to establish strong connections with people at the firm who I have not had the opportunity to work with directly, and have assisted me in developing skills in organising and participating in various events, which has boosted my confidence in the workplace. It has been fantastic to be involved in the WISE network and to experience the firm's dedication to diversity and inclusion first hand. Likewise, bonding with other juniors in the office through the JPC has been really valuable.


